NOTICE TO EXHIBITORS

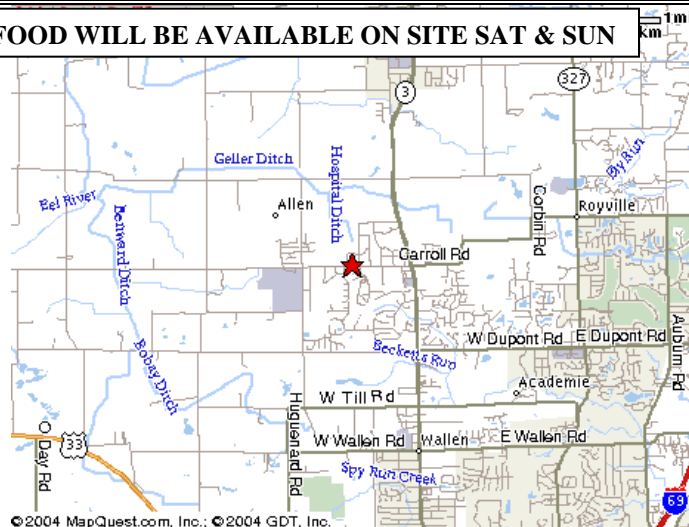
