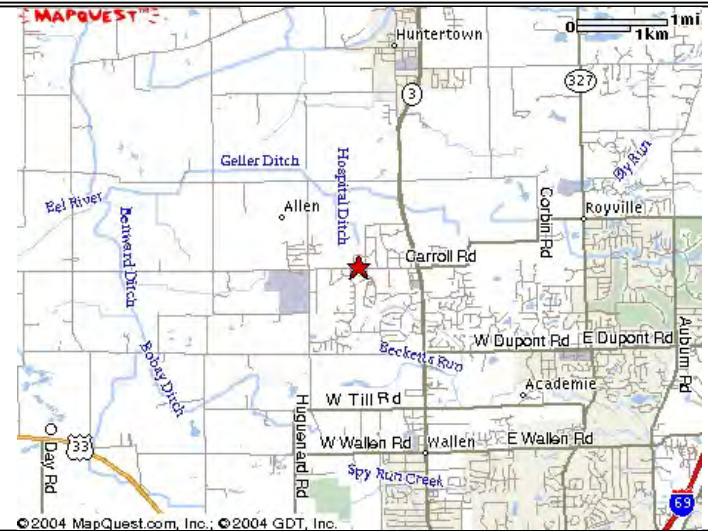
**DIRECTIONS TO THE EMERGENCY VET:** From the trial site, take Carroll Road to Lima Road. Turn right (south) onto Lima Road. Go to Dupont Road. Turn left (east) onto Dupont Road. Go to I-69. Take I-69 South. Exit onto 469. Follow 469 to Maplecrest Road, and go south. The Emergency Vet Clinic will be past the intersection of St. Joe Center Road on the left (east) side of the road.

**DIRECTIONS TO THE SHOW SITE:** From I-69 South, take Exit #316, Dupont Road, West (right off of exit ramp). Travel approximately three miles, to Lima Road (Hwy. 3). Turn North (right) onto Lima. Continue for one mile, and turn left at the next traffic light, heading West on Carroll Road. The fairgrounds entrance is one mile on the right. From I-69 Northbound, Exit at #311B, heading North on Lima Rd./Hwy. 3. Turn left (West) on Carroll Road, for one mile. The entrance is on the right (North) side of the road.
