In accordance with Ch. 1 Sec 17 of the AKC Tracking Regulations, a random draw to fill entry limits will be held at the home of the test secretary and open to all interested persons. Priority will be given to dogs that do not hold a title. Alternates will be given the option to accept or decline being placed on the alternates list. Those who accept will be placed on the alternates list in the order in which they were drawn. Those who decline will have their entry fee check shredded. Entrants and alternates who do not run in a test and are replaced by alternates who run in the test will have entry checks shredded. Following the draw, the test secretary will attempt to contact all entrants and advise them of the outcome within 48 hours. In the event an accepted entry is absent on the day of the test, the first alternate entry present according to the order in which they were drawn shall assume the vacant position.

No entries will be accepted which require a signature for delivery. Entries will not be accepted without fee. Returned checks do not constitute a valid entry fee. Test Secretary will add the fee charged by the bank to the amount of each returned check. Faxed, telephone, E-mail, and unsigned entries cannot be accepted. Entries not on an official AKC form are not accepted. Owners are responsible for errors in filling out entry forms and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge or barred from competition by action of Tracking Committee. If because of riots, civil disturbances, or acts beyond control of FWOTC and/or the Tracking Committee it is impossible to start or complete the test, no refund of entry fee will be made.
